

Bulls i Toy Scholastic Wings of Fire Giveaway Official Rules

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

BY PARTICIPATING IN THIS PROMOTION , YOU AGREE TO THESE OFFICIAL RULES (“RULES”).

1. SPONSOR:

Canspan BMG, located at 3700 St-patrick Ste 314, Montreal, Quebec, H4E 1A2, Canada and Bulls i Toy, located at 5501 Park Ave., Des Moines, Iowa 50321 (“**Sponsor**”).

2. ELIGIBILITY:

Bulls i Toy x Scholastic Wings of Fire Giveaway (“**Promotion**”) is open only to legal residents of the 50 United States and the District of Columbia (“**Territory**”) who are at least eighteen (18) years of age or older at the time of entry (or the age of majority in their jurisdiction of residence, whichever is older). Void in Guam, Puerto Rico, the U.S. Virgin Islands, and other U.S. territories and possessions and where prohibited by law. Employees of Scholastic, Sponsor or any organizations responsible for administering, fulfilling, advertising or promoting this Promotion and/or their respective parent, subsidiary, affiliated and successor companies (collectively, “**Promotion Entities**”) and their immediate family members and household members are not eligible to enter or receive a giveaway prize. “**Immediate family member**” shall mean parents, step-parents, children, step-children, siblings, step-siblings, or spouses, regardless of where they live. “**Household member**” shall mean people who share the same residence at least three (3) months a year, whether related or not. 3. ENTRY PERIOD:

This Promotion begins on Tuesday, March 10, 2025, at 10:00 a.m. Eastern Standard Time (“EST”) and ends on Tuesday, March 18, 2024, at 11:59 p.m. EST (the “Promotion Period”). For purposes of these Rules, all times and days are Eastern Standard Time and Sponsor’s computer will be the clock for all matters related to this Promotion.

4. How to Enter

To participate in this Promotion, you must have an active Instagram or Facebook account. If you do not have an Instagram or Facebook account, you may download the Instagram or Facebook app from the Apple App Store or Google Play onto a compatible mobile device or visit [Instagram](#) or [Facebook](#) to create an account according to the instructions provided. Creating an account is free. You must accept the applicable **Instagram Terms** at [Instagram’s Terms](#) or **Facebook Terms** at [Facebook’s Terms](#) to create an account, and you must be logged in to your account to enter this Sweepstakes.

You may enter on **Instagram** by (i) following **@bullsitoys**, **@tuisutherland**, and **@scholastic** on Instagram; (ii) liking the Giveaway Announcement post; and (iii) tagging at least one friend in the comments of the Giveaway Announcement post. You may tag multiple friends, but this will count as a

single entry. For **one (1) Bonus Entry**, you may (iv) share the Giveaway Announcement post to your Instagram Stories.

You may also enter on **Facebook** by (i) following **Bullsitoy** on Facebook; (ii) liking the Giveaway Announcement post; and (iii) commenting on the post by tagging at least one friend. Similar to Instagram, tagging multiple friends will count as a **single entry**. For **one (1) Bonus Entry**, you may (iv) share the Giveaway Announcement post to your Facebook timeline.

All Entries must be posted during the Entry Period to be eligible. Proof of submission of Entry does not constitute proof of receipt of same. By entering this Promotion, entrants agree to these Rules and the decisions of Sponsor, which are binding and final in all matters relating to this Promotion and not subject to appeal. Elements of each prize will be determined at the sole discretion of Sponsor. Winners are not entitled to exchange or transfer a prize or to obtain cash or other substitutes, except Sponsor reserves the right to substitute a prize or portions thereof of equal or greater value if a prize listed or any portion thereof is unavailable for any reason.
